  - To participate in bidding process bidders, must get digital signature certificate (DSC) as per information technology-2000 bidders can get digital certificate from approved option as well as from "Bidders Manual Kit" on website ([jktenders.gov.in](http://jktenders.gov.in)) to acquaint vendors.
  - The bidders have to submit their bids online in electronic format with digital signature.
  - Bids must be accompanied by bid security deposit & cost of tender document as specified in column (5&6) of the above table. Bid security will be in the shape of CDR/FDR pledged in favour of **Executive Engineer, Jal Shakti (PHE) Division Pulwama** and the cost of tender document shall be deposited in the Treasury under MH 0215 PHE in favour of **Executive Engineer, Jal Shakti (PHE) Division Pulwama**.

- Bidders must ensure to upload scanned copy of all necessary documents in terms of soft copies with the technical bid and no documents in terms of hard copies shall be entertained. However, in case of any clarification the bidders shall have to produce original documents in support of soft copies if need arises.

- The original instrument in respect of Treasury Receipt, EMD and relevant attested copies of Technical Bid Documents as specified above must be submitted by Lowest Bidder (L1) to **Executive Engineer, Jal Shakti (PHE) Division Pulwama** by hand or by speed/registered post before processing of allotment. If the bidder fails to produce the same within the prescribed time period, he will be debarred from taking part in tendering process in this division for at least two years.
- No financial bid will be accepted in physical form.
- The bid shall be deposit in electronic format only on the web site of ([jktenders.gov.in](http://jktenders.gov.in))
- The bid(s) shall be opened online on above mentioned date or any other subsequent date in presence of the tender opening committee to be constituted by the competent authority.
- No claim shall be entertained on account of disruption of internet services being used by bidders and are advised to upload their bids well in advance to avoid any technical snags in last hours.

### **GENERAL TERMS AND CONDITIONS:**

- 1- The 1st Lowest bidder has to produce CDR / FDR for an amount of Rs.1350/- (Earnest Money) in original within one day after the generation of comparative chart and the same shall be released after successful completion of job.
- 2- The payment shall be made under JJM (contingencies) in accordance with circular No. A/51/2016)-B-927/J dated. 08-01-2021 as authorized by MD JJM J&K vide No. SDM/JJM-J&K/39/2023-24/163-65 Dated. 05-06-2023 followed by DJJM Pulwama's No. DDCP/Capex/JJM/2023-24-242-44 Dated. 09-06-2023.
- 3- The payment shall be made on the production of verified bill from the Project Manager DPMU Pulwama duly supported by attested log book.
- 4- Bidders must ensure to upload their bids in Singe Cover.
- 5- Rates are to be quoted per day basis for the categories of vehicle including POL.
- 6- Rates are to be quoted by the bidder included all taxes.
- 7- The Bidder shall ensure that the vehicle/driver should not be changed frequently. Any such change(s) should be informed to the authority well in advance.
- 8- The tender/bid shall remain valid for a period of 90 (Ninety) days from the date of opening of the tender.
- 9- The bid shall be uploaded in electronic format on the departmental website [jktenders.gov.in](http://jktenders.gov.in)
- 10- The Earnest Money Deposit shall be forfeited if:-
  - a. Any Tenderer withdraws his bid during the period of validity of tender or makes any modification in terms and conditions of the e-NIT.
- 11- The tenderer shall have to execute the agreement within 07-days after fixation of contract.
- 12- The vehicle must be in a fit & fine condition and having valid manufacturing/Regn. not before the year 2013. The vehicle having manufacturing date before the said year shall not be accepted in any case.
- 13- The tender receiving authority reserves the right to accept or reject any or all tenders without assigning any reason thereof.
- 14- The tender/bid is liable to rejection if it does not full fill the requirements as laid down in e-NIT.
