| 2 | <i>The work shall have to be completed within a period of 60 days from the date of issuance of this allotment order failing which penalty upto 10% of the total value of contract shall be imposed upon you.</i> |
| 3 | <i>The earnest money shall be deposited in the shape of CDR/FDR/BG within seven after issuance of this allotment as per the terms and conditions of NIT/SBD.</i> |
| 4 | Client/Paying Authority: <i>The client/paying authority shall be the concerned Executive Engineer. Besides, the supervision of the various components of the work shall be carried out by the concerned Engineers of the Division/TPIQM consultants under the overall coordination of the concerned Superintending Engineer Hydraulic Circle/Executive Engineer/Assistant Executive Engineer</i> |
| 5 | Terms of Payment: <i>Payment can be claimed on a monthly basis subject to the amount of bill being proportionate to the value of work viz a viz completion period within a variation of -5%.</i> |
| 6 | Warranty: <i>The firm shall be bound for satisfactory performance of works for 18 months after the successful commissioning of subject work. If during warranty period any malfunctioning/ defects arise, the firm /joint venture shall have to rectify the same within a period of ten days of receipt of intimation. 
