Governor of Jammu and Kashmir (U.T), the contract for work, 'Construction/Testing/Commissioning of 0.20 lac gallon capacity OHT of shell type with staging height of 20 mtrs including construction of sluice chamber at Genie Mohalla Humhama Water Supply Scheme Genie Mohalla Humhama' is hereby fixed with you in accordance with all the terms and conditions as laid down in the bid document read with the amendment / corrigendum if any, for an amount of Rs. 57,64,319.306/- (Rupees Fifty-Seven Lacs Sixty Four Thousand Three Hundred Nineteen only) as per the following item rates along-with your quoted overall tender appreciation of (8%) Eight percent as per Annexure (A). This is continuation to the letter of intent referred above.

Note:-

- 1) Total value of the work is Rs. 57,64/- Lacs worked out on the basis of quoted rates as per Annexure (A) which includes all taxes, levies etc.
- 2) The date of start of the subject work shall be reckoned from the date of Issuance of this allotment order. Given the fact that Letter of Intent stands already stands issued by the Superintending Engineer, Hyd, Circle Budgam vide his letter No. SE/Hyd/1012-15 Dated 23.05.2022, in case of failure to start the work within three days of issuance of this allotment order action as warranted shall be initiated.
- 3) As soon as letter of award is communicated to the firm, the contract shall be complete and binding upon them, the bidder/firm shall also be required to execute an agreement with the competent authority within seven days from the date of issue of letter of award. Failure to execute such an agreement in time shall not however, prevent this contract from being enforced against the firm and the date of delivery of the material/completion of works shall be reckoned from the date of issue of the letter of award in favour of successful firm.
- 4) Performance security equivalent to 03% of the value of the contract which works out to Rs. 173905/- valid in accordance with bid conditions, shall have to be furnished by you in shape of CDR/FDR/BG within one week from the date of issuance of this allotment failing which your contract shall be seized and the earnest money shall be forfeited.
- 5) The work shall have to be completed within a period of 150 working days from the date of issuance of this allotment order failing which penalty up to 10% of the total value of contract shall be imposed upon you.
- 6) The defects Liability period shall be for a period of 12 Months which shall commence after the successful completion of Trial run, during the defects Liability period (DLP) the agency have to operate & maintain the scheme as it is required for its successful running & as per Standard Engineering Practices, to the full satisfaction of the department. The agency shall be responsible to make good & remedy at his own expense any defect in works which is noticed during the DLP. In case any defect remains unattended by the agency at the completion of DLP, the department may extend the DLP for such time as deemed fit for getting the defect rectified subject to a maximum ceiling of 6 Months
- 7) All other terms and conditions and technical specifications shall remain the same as laid down in the Standard Bid Document of the subject e-NIT and Terms & Conditions thereof read with the corrigenda. Minutes of pre-bid meeting/GFR 2017 and manual for procurement of works 2019.
