

B). Terms and Conditions:-

1. This letter of allotment and tender of the contractor will constitute a legal contract and the conditions as laid down in the detailed NIT/PWD form No:-25 & 33 (Double leaf) and hold good even before the drawal of agreement between the contractor and the Department.
2. The contractor is directed to attend the Divisional Office along-with his registration card for drawal of an agreement within a period of (07) days from the date of issuance of this letter of allotment and non-drawal of agreement with the Department does not exclude you from contractual obligations.
3. The total amount of the work on your above quoted rates works out to be Rs.1.05.600/- (Rupees: One lac. Five thousand & Six hundred) only.
4. The work is to be completed within a period of 07 days to be reckoned after 3 days from the date of issue of this allotment. In case of any delay caused in the execution of work, penalty upto 10% shall be imposed upon the contractor or the department shall be at liberty to terminate the contract in part or in full (as the case may be) and the contract shall be completed through same other available sources at the risk and cost of the defaultiy agency after serving not more than two notices which should be strictly noted.
5. CDR Nos:- 2888947 dated:-08.12.2020 for Rs.800/- & No. 2888992. dated:- 27.01.2021 for Rs.2000/- are retained in the divisional office as security against the said work and will be released after successful testing, commissioning and handing over the complete contract to the department and additional performance deposit in the shape C.D.R bearing Nos:- 2994882 dated:-01.12.2020 for Rs.1200/- & No.2888994 dated:-05.02.2021 for Rs.5500/- only.
